POLICY DISCUSSION

Policies/Regulations/Exhibits to be Presented for Public Review for Four Weeks: Policy BCBG – Voting Method (Reviewed)

The Board placed Policy BCBG – Voting Method on the Table for four weeks. Review was requested because a sentence has been added specifically permitting participation and voting by telephone to the extent permitted by the Georgia Open Meetings Act. The Committee should address whether such participation does or does not include executive sessions.

Policy GAAA - Equal Opportunity Employment (Revised)

The Board placed Policy GAAA – Equal Opportunity Employment on the Table for four weeks. The revision is recommended because it was noticed that some but not all policies include gender identity and sexual orientation as prohibited bases of discrimination on those bases.

Policy JBCD – Transfers and Withdrawals (Revised)

The Board placed Policy JBCD – Transfers and Withdrawals on the Table for four weeks. Revisions were made to correct addresses, to clarify second paragraph and to eliminate conditional admission.

Policy JRA - Student Data Privacy Complaints (New)

The Board placed Policy JRA – Student Data Privacy Complaints on the Table for four weeks. The proposed policy is taken from GSBA's Policy Alert, and is substantially identical to the model policy promulgated by GDOE.

Exhibit JRA-E(1) - Student Data Privacy Complaints (New)

The Board placed Exhibit JRA-E(1) – Student Data Privacy Complaints on the Table for four weeks. The Student Data Privacy, Accessibility, and Transparency Act requires a policy for complaints but does not expressly require a form. A form is recommended, however, to standardize the process and avoid confusion to parents and administrators.

Approve Ratification of Emergency Sewer Repair - Clarke Middle (Plant Services)

The Board approved the ratification of payment to King Plumbing Company as outlined for a total of \$22,028.00. Funding will come from Plant Service's budget.

Approve Purchase of School Buses – State of GA Bond Funding (Transportation)

The Board approved the purchase of three (3) new 72 passenger Blue Bird school buses with related equipment from Yancey Bus Sales and Service utilizing State of Georgia contract pricing for a total purchase price of \$286,605. Funding of \$231,648.75 is from the State of Georgia Bond fund and \$54,956.25 is from the Transportation Department budget. In the event the bus delivery date extends beyond the end of the FY 2017 fiscal year, funds for this purchase shall carry over to the FY 2018 Transportation Department budget.

Approve Purchase of School Buses - (SPLOST Transportation)

The Board approved the purchase of one (1) new 72 passenger conventional Blue Bird bus and two (2) new 72 passenger wheel chair Blue Bird buses with related equipment from Yancey Bus Sales and Service utilizing State of Georgia contract pricing for a total purchase price of \$307,205. Funding is from the SPLOST 4 Transportation budget.

Approve Department of Behavioral Health and Development Disabilities Contract for Alcohol Use/Abuse Prevention Services Grant

The Board approved fiscal year 2017 funding from the Department of Behavioral Health and Developmental Disabilities Contract for Alcohol and Substance Abuse Prevention for the Clarke County School District in the amount of \$244,368.00 for the first year of a five year contract cycle.
