(TRANSPORTATION DEPARTMENT)

All respondents are hereby advised of the following amendments to the Request for Proposals ("RFP") document which are hereby made an integral part of the proposal documents for the subject contract, prepared by the Clarke County School District ("CCSD or District").

Proposals submitted shall be deemed to include contract document information as shown in **ADDENDUM NO. 3**. Respondents shall be required to acknowledge receipt of this addendum in their proposal response. Failure to acknowledge receipt of this addendum by the respondent may result in the rejection of their proposal response.

This addendum must be completed, signed and submitted with your proposal response to be considered for award. If you have already submitted a proposal, please complete the addendum and submit same in a sealed envelope, clearly marked with the "RFP# 24-0117, DIGITAL VIDEO SURVEILLANCE SYSTEM FOR BUSES (TRANSPORTATION DEPARTMENT)", response date, and return address. This will be accepted as part of your proposal response, PROVIDING IT IS RECEIVED BY THE PURCHASING DEPARTMENT BY THE TIME AND DATE SPECIFIED IN THIS DOCUMENT.

The Addendum becomes a part of the Original document and Modifies, as noted below:

- A. MODIFICATIONS & REVISIONS (clarifications in red)
  - 1. Date for posting of Questions & Answers on the website has been extended to: TUESDAY, JANUARY 16, 2024 5:00 PM (EST)
  - Proposal Due Date has been extended to: TUESDAY, FEBRUARY 13, 2024 – 11:00 AM (EST)
  - 3. ADD: 4.0 REQUIRED FOR PROPOSAL SUBMISSION
    - A. Total number of buses included in the RFP has been revised; 121-total.
    - B. Brochures, program reports, evaluations, or other evidence of past program experience and performance;
    - C. After internal conversations, for the **Stop Arm Cameras** that are being requested within the RFP, we would like the vendor to be provide video monitoring which would consist of the following, but not limited to:
      - Interested proposer shall include detail of how the stop arm cameras would be provided, installed, maintenance, and back-office services of the school bus safety camera enforcement system;
      - ii. This should consist of cameras capturing both still and video images illegally overtaking and passing a stopped school bus displaying the deployed stop arm;
      - iii. CCSD intends to equip 121 buses;
      - iv. The CCSD school bus stop arm camera enforcement shall operate pursuant to the laws, codes, and ordinance of Athens-Clarke County and the state of Georgia;

- v. All such video-monitoring systems shall produce clear images, produce recorded image of the license plate through geographic positioning at the time of the violation, the activation status of the camera, and the time, date, and location of the vehicle when the image is recorded:
- vi. The interested Proposer shall make changes to the system as necessary to conform to the current law and regulations and to any changes in the law or regulations at no cost to the District:
- vii. Detail how your company will work with the District in establishing clear protocols and deployment related to the stop camera management;
- viii. Detail how your company will provide data security/privacy for stop cameras;
- ix. Detail citation management that your company will provide for the District for the Stop Arm Camera system:
- x. Detail how your company will provide violation processing, to include violation data and reporting;
- xi. Detail how your company will work with CCSD in resolving citizen inquiries or complaints concerning the use of school bus camera enforcement; and
- xii. Detail how the payment for citations will be processed and deposited. What portions of these citations will be provided to the District?

## B. QUESTIONS & ANSWERS (clarifications in red)

- 1. **Q:** Can CCSD please confirm if they are wanting wireless infrastructure quoted (access points/video downloading via WIFI at yards)? If so, could CCSD describe the current existing wireless infrastructure as well as all addresses where such WIFI infrastructure is desired?
  - A: We would prefer a cell-based system. The Wi-Fi has shown many failures in the past.
- 2. **Q**: of the 144 vehicles, how many require a stop arm camera? **A**: After further review, the total is 121; please quote all in your proposal response.
- 3. **Q:** Which cell carrier provides the best coverage for CCSD? Who Is CCSD's preferred cellular provider?
  - A: Verizon
- Q: For 2.5.2, is a bond required for this bid?
   A: No
- 5. **Q:** For 7.4, is wi-fi or cellular download preferred? Or both options? Do you have a current cellular data provider?
  - **A:** We prefer cellular. Verizon is the current cellular data provider.
- 6. Q: Can you also please provide more info on the existing CCSD communications infrastructure? (number of Wi-Fi access points, connection limitations, etc.)
  A: Buildings have internal Wi-Fi, but nothing outside; access points are located in most rooms. The system is very limited and that is why we really want cellular based.
- 7. **Q:** If a vendor is to provide cellular data plans, is there a desired data amount per month? **A:** Offerors should propose what is needed to meet the need of pulling live data off buses. Proposers can also provide several pricing options in their response.
- 8. **Q:** Regarding 5.1 & 5.2, would a lease option be acceptable over a 3-year period or no? **A:** We may opt to a 1-year with 4- renewals. Please provide a 3 and 5- year pricing option for review.

- 9. Q: Would an extension for the due date be entertained?A: We have extended the proposal due date to Tuesday, February 13, 2024.
- 10. **Q:** Is it possible to provide an image of the 24/7 camera connector that plugs into the existing DVR? **A:** Please see attached.
- 11. **Q:** Is it possible to provide an image of the REI camera connector that plugs into the existing DVR? **A:** Please see attached.
- 12. Q: During the video conference, it was mentioned that additional time for submission may be considered. We have reviewed the scope of requirements and feel that additional time could help us put forward the best proposal for Clarke County School District. Would you consider moving the deadline to January 31st?
  - **A:** We have extended the proposal due date to Tuesday, February 13, 2024.
- 13. **Q:** Should we submit a cost per vehicle or is there a vehicle amount we should price, given that Clarke County has provided a list of busses but has also indicated that they may choose to maintain some of the more present camera systems?
  - **A:** If possible, a cost per vehicle would be helpful, but if you provide cost for a total of 121 buses, that would be fine.
- 14. **Q:** Aside from the older Camera Systems that are expected to be replaced, are there any other technologies in place on Clarke County Buses such as GPS Systems, Tablets and On-board bus Wi-Fi?
  - A: We have GPS and W-Fi that comes with it; but that system is staying on the buses.
- 15. **Q:** If there is onboard bus Wi-Fi can you provide the make and model of the mobile router. **A:** It is Samsara and they use the VG34 Gateway which has a Wi-Fi access.
- 16. **Q:** Will Clarke County need the optional cellular connectivity and/or live view? **A:** We prefer cellular connectivity to include live view.
- 17. Q: Will the recording be available for the pre-proposal conference from January 4, 2024?A: Please click here to review the pre-proposal conference video. Password: Transportation#1
- 18. Q: Can you provide details on the units in each bus.
  - **A:** Please see the spreadsheet attached; please review all buses 2010 or newer. You should be proposing a total of 121 buses.
- 19. Q: Due to the clarifications and changes in scope of work for this RFP specifically around the stop arm portion, our team at Verra Mobility is requesting an extension until February 9<sup>th</sup>, 2024. This will give us the time to properly respond to the updated scope of work and clearly show our capabilities in the additional areas requested.

A: We have extended the proposal due date to Tuesday, February 13, 2024.
