The Clarke County School District ("CCSD or District") is seeking qualified ("Proposers") to submit proposals for **REPLACEMENT FLOORING at the Office of Early Learning-West campus.** Sealed proposals from qualified firms will be received by the Clarke County School District in the Office of Purchasing & Contracts, 595 Prince Avenue, Athens, Georgia, 30601, until **11:00 AM (EDT) on MAY 23, 2024.** Proposals shall be submitted via email.

A Mandatory Pre-Proposal Conference & Site Visit will be held for interested vendors at <u>9:00 AM (EDT)</u> on <u>MAY 10.</u> <u>2024</u>. This conference will be held at the Office of Early Learning-West, 440-2 Dearing Extension, Athens, Georgia 30601. No alternate dates will be available; please review the solicitation prior to the meeting. The purpose of this conference is to allow potential Offerors an opportunity to present questions and obtain clarification relative to any facet of this solicitation. All Proposers expecting to respond to this RFP are encouraged to attend this meeting at the time and location described herein. Any changes resulting from this conference will be issued in a written addendum to the solicitation.

Failure to comply with the written requirements for this proposal may result in rejection of the proposal by the Clarke County School District.

The contract, if awarded, will be on the basis stated in the Request for Proposal and Specification. No proposals may be withdrawn for a period of sixty (60) days.
